Financial Agent for British Columbia Patriot Party:

We have audited the annual financial report of the British Columbia Patriot Party for the year ended December 31, 2008. This annual financial report is your responsibility as the financial agent for the British Columbia Patriot Party. Our responsibility is to express an opinion on this annual financial report based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards and the requirements of section 214 of the Election Act. Canadian generally accepted auditing standards require that we plan and perform an audit to obtain reasonable assurance whether the annual financial report is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the annual financial report. An audit also includes assessing the accounting principles used and significant estimates made by the financial agent, as well as evaluating the overall presentation of the annual financial report.

Due to the nature of the transactions inherent in any registered Political Party/Constituency Association, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these transactions was limited to the amounts recorded in the British Columbia Patriot Party records and we were not able to determine whether any adjustments might be necessary to the annual financial report.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves as to the completeness of the British Columbia Patriot Party records as described in the preceding paragraph, this annual financial report presents fairly, in all material respects, the financial position of the British Columbia Patriot Party as at December 31, 2008 and its financial transactions for the year then ended in accordance with the requirements of Part 10 of the Election Act.

This annual financial report, which has not been, and was not intended to be, prepared in accordance with Canadian generally accepted accounting principles, is solely for the information and use of the Chief Electoral Officer to comply with Part 10 of the Election Act. The financial report is not intended to be and should not be used by anyone other than the specified users or for any other purpose.
