#### INDEPENDENT AUDITOR'S REPORT

Financial agent's responsibility for the financing report

The Financial Agent is responsible for the preparation of the financing report in accordance with the financial reporting provisions of Part 10 of the Election Act, and for such internal control as the financial agent determines is necessary to enable the preparation of financing reports that are free from material misstatement, whether due to error or fraud

#### Auditor's Responsibility

Our responsibility is to express an opinion on the financing report based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards as required by Section 214 of the Election Act (British Columbia). Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financing report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financing report.
