INDEPENDENT AUDITOR'S REPORT

Financial agent's responsibility for the election financing report

The Financial Agent is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian generally accepted accounting principles, and for such internal control as management determines is necessary to enable the preparation of election financing reports that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility
