**Independent Auditor's Report
Leadership Contestant Financing Report
Pursuant to the *Election Act* (British Columbia)**

To: Brian Hanna, Financial Agent for Evelyn Stilwell

We have audited the accompanying leadership contestant financing report of Evelyn Stilwell relating to the British Columbia Liberal Party leadership contest held on February 26, 2011. The leadership contestant financing report has been prepared by the Financial Agent for Evelyn Stilwell based on the financial reporting provisions of Part 10 of the *Election Act*.

Financial Agent's responsibility for the leadership contestant financing report

The Financial Agent is responsible for the preparation of the leadership contestant financing report in accordance with the financial reporting provisions of Part 10 of the *Election Act*, and for such internal control as the Financial Agent determines is necessary to enable the preparation of leadership contestant financing reports that are free from material misstatement, whether due to error or fraud.

Auditor's responsibility

Our responsibility is to express an opinion on the leadership contestant financing report based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards as required by Section 214 of the *Election Act*. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the leadership contestant financing report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the leadership contestant financing report. The procedures selected depend on the auditor's judgment, including the assessment of risks of material misstatement of the leadership contestant financing report, whether due to error or fraud. In making those risk assessments, the auditor considers internal control relevant to the Financial Agent's preparation of the leadership contestant financing report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the leadership contestant's internal control. An audit also includes evaluating the appropriateness of accounting policies used and reasonableness of accounting estimates made by the Financial Agent, as well as evaluating the overall presentation of the leadership contestant financing report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.



Basis for qualified opinion

Due to the nature of the transactions inherent in any leadership campaign, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these transactions was limited to the amounts recorded in the campaign records and we were not able to determine whether any adjustments might be necessary to the leadership contestant financing report.

Qualified opinion

In our opinion, except for the effects of the matter described in the basis for qualified opinion paragraph, the leadership contestant financing report of Evelyn Stilwell for the British Columbia Liberal Party leadership contest held on February 26, 2011 is prepared, in all material respects, in accordance with the financial reporting provisions of Part 10 of the *Election Act*.

Basis of accounting

The leadership contestant financing report is prepared to assist Evelyn Stilwell to comply with the financial reporting provisions of Part 10 of the *Election Act*. As a result, the leadership contestant financing report may not be suitable for another purpose.
