INDEPENDENT AUDITOR'S REPORT

To: Francisca J Fenton, Financial Agent for the BC Conservative Party

I have audited the accompanying **ELECTION FINANCING REPORT** for the BC Conservative Party relating to the British Columbia election held on May 14, 2013. The election financing report has been prepared by the Financial Agent for BC Conservative Patty based on the financial reporting provisions of Part 10 of the *Elections Act*.

Financial agent's responsibility for the Election Financing Report

The Financial Agent is responsible for the preparation of the Election Financing Report in accordance with the financial reporting previsions Part 10 of the *Election Act*, and for such internal control as the financial agent determines is necessary to enable the preparation of the Election Financing Reports that are free from material misstatement, whether due to error or fraud.

Auditor's responsibility

My responsibility is to express and opinion on the Election Financing Report based on my audit. I conducted my audit in accordance with Canadian generally accepted auditing standards as required by Section 214 of the *Election Act* (British Columbia). Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Election Financing Report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Election Financing Report. The procedures selected depend on the auditor's judgment, including the assessment of risks of material misstatement of the Election Financing Report, whether due to error or fraud. In making those assessments, the auditor considers internal control relevant to the Financial Agent's preparation of the Election Financing Report I order to design auditor procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the BC Conservative Party's internal control. An Audit also includes evaluating the appropriateness of accounting policies used and reasonableness of accounting estimates made by the Financial Agent, as well as evaluating the overall presentation of the Election Financing Report.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.



Basis for Qualified Opinion

Due to the nature of the transactions inherent to any political party, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, my verification of these transactions was limited to the amounts recorded in the BC Conservative Party records and I was not able to determine whether any adjustments might be necessary to the report.

Qualified Opinion

In my opinion, except for the effects of the matter described in the Basis for Qualified Opinion paragraph, the Election Financing Report of the BC Conservative Party relating to the British Columbia election held on May 5, 2013, is prepared, in all material respects, in accordance with the financial reporting provisions of the Election Act (British Columbia).

Basis of Accounting

The Election Financing Report is prepared to assist the BC Conservative Party to comply with the reporting provisions of Part 10 of the *Election Act*. As a result, the Election Financing Report may not be suitable for any other purpose.
