Independent Auditor's Report

To Ian McMorland, Financial Agent for Greg Kylo

We have audited the accompanying Election Financing Report ("Report") of Greg Kylo relating to the British Columbia election held on May 9, 2017 in the electoral district of Shuswap. The Report has been prepared by the Financial Agent for Greg Kylo based on the financial reporting provisions of Part 10 of the Election Act.

Financial Agent's Responsibility for the Election Financing Report

The Financial Agent is responsible for the preparation of the Report in accordance with the financial reporting provisions of Part 10 of the Election Act, and for such internal control as the financial agent determines is necessary to enable the preparation of a Report that is free from material misstatement, whether due to error or fraud.

Auditor's Responsibility

Our responsibility is to express an opinion on the Report based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards as required by Section 214 of the Election Act (British Columbia). Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Report. The procedures selected depend on the auditor's judgment, including the assessment of risks of material misstatement of the Report, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Financial Agent's preparation of the Report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal controls. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Financial Agent, as well as evaluating the overall presentation of the Report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Basis for Qualified Opinion

Due to the inherent nature of the transactions in any election campaign, the completeness of contributions and other revenues and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these transactions was limited to the amounts recorded in the election campaign records and we were not able to determine whether any adjustments might be necessary to the Report.



Qualified Opinion

In our opinion, except for the possible effects of the matters described in the Basis for Qualified Opinion paragraph and Note 2 to the Report, the Report of Greg Kylo for the British Columbia election held on May 9, 2017 in the electoral district of Shuswap is prepared, in all material respects, in accordance with the financial reporting provisions of Part 10 of the Election Act.

Basis of Accounting

Without modifying our opinion, we draw attention to Note 1 in the Report, which describes the basis of accounting. The Report is prepared to assist Greg Kylo to comply with the financial reporting provisions of Part 10 of the Election Act. As a result, the Report may not be suitable for another purpose.
