### **Independent Auditors' Report**

To Vilja Jaako, financial agent for Val Litwin

We have audited the accompanying Leadership Contestant Financing Report of Val Litwin relating to the BC Liberal Party leadership selection held on February 5, 2022. The Leadership Contestant Financing Report has been prepared by the financial agent for Val Litwin based on the financial reporting provisions of Part 10 of the Election Act.

#### Financial agent's Responsibility for the Leadership Contestant Financing Report

The financial agent is responsible for the preparation of the Leadership Contestant Financing Report in accordance with the financial reporting provisions of Part 10 of the Elections Act, and for such internal control as the financial agent determines is necessary to enable the preparation of the Leadership Contestant Financing Report that is free from material misstatement, whether due to fraud or error.

#### **Auditors' Responsibility**

Our responsibility is to express an opinion on the Leadership Contestant Financing Report based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards as required by Section 214 of the Elections Act (British Columbia). Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Leadership Contestant Financing Report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Leadership Contestant Financing Report. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement of the Leadership Contestant Financing Report, whether due to fraud or error. In making those risk assessments, the auditors consider internal control relevant to the financial agent's preparation of the Leadership Contestant Financing Report in order to design audit procedures that are of Val Litwin's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the Leadership Contestant Financing Report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

### **Basis for Qualified Opinion**

Due to the nature of the transactions inherent in any leadership campaign, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these transactions was limited to the amounts recorded in the campaign records and we were not able to determine whether any adjustments might be necessary to the Leadership Contestant Financing Report.

### **Qualified Opinion**

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the Leadership Contestant Financing Report of Val Litwin for the BC Liberal Party leadership selection held on February 5, 2022 is prepared, in all material respects, in accordance with the financial reporting provisions of Part 10 of the Election Act.

### **Basis of Accounting**

The Leadership Contestant Financing Report is prepared to assist Val Litwin to comply with the financial reporting provisions of Part 10 of the Election Act. As a result, the Leadership Contestant Financing Report may not be suitable for another purpose.

#### **Other Matter**

Subsequent to the initial issuance of the Independent Auditors' Report dated June 6, 2022, it was determined by management that changes to the Campaign Expenses were required. The changes were due to repayments received and additional transfers and expenses reported relating to the election period. Reports Sm-E-L, Sm-PE and S-TRF have been updated to reflect the changes.

Further testing has been completed on the subsequent expense changes following procedures outlined in the 'Auditors' Responsibility'.
