

We have audited the candidate's election financing report (pursuant to Part 10 of the *Election Act*) for the candidacy of Val Roddick, a candidate at the election of a member to serve in the Legislative Assembly of British Columbia held on the 17th Day of May 2006 in the electoral district of South Delta. This election financing report is your responsibility as the financial agent for Val Roddick. Our responsibility is to express an opinion on this election financing report based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the election financing report is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the election financing report. An audit also includes assessing the accounting principles used and significant estimates made by the financial agent, as well as evaluating the overall presentation of the election financing report.

Due to the nature of the types of transactions inherent in any election campaign, it is impracticable through auditing procedures to determine that the Financial Agent's election campaign records include all financial transactions for the campaign. Accordingly, our verification of these transactions were limited to the amounts recorded in the Financial Agent's election campaign records and we were not able to determine whether any adjustments might be necessary to the election financing report.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves as to the completeness of the Financial Agent's election campaign records as described in the preceding paragraph, this election financing report presents fairly, in all material respects, the financial transactions contained in the Financial Agent's campaign records, in accordance with the requirements of Part 10 of the *Election Act*.
