Auditor's Report on
British Columbia Patriot Party's Annual Financial Report
Pursuant to the *Election Act*

To Dr. Andrew Hockhold, Financial Agent for the British Columbia Patriot Party

We have audited the annual financial report (*pursuant to Part 10 of the Election Act*) of the British Columbia Patriot Party for the year ended December 31, 2006. This annual financial report is your responsibility as Financial Agent for the British Columbia Patriot Party. Our responsibility is to express an opinion on this annual financial report based on my audit.

Except as explained in the following paragraph, we conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the annual financial report is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the annual financial report. An Audit also includes assessing the accounting principles used and significant estimates made by the Financial Agent, as well as evaluating the overall presentation of the annual financial report.

Due to the nature of the transactions of any political party, it is impracticable through auditing procedures to determine that the Financial Agent's political party records include all financial transactions for the political party. Accordingly, our verification of these transactions was limited to the amounts recorded in the Financial Agent's political party records and we were not able to determine whether any adjustments might be necessary to the annual financial report.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy myself as to the completeness of the Financial Agent's political party records as described in the preceding paragraph, this political party's annual financial report presents fairly, in all material respects, the financial transactions contained in the Financial Agent's records, in accordance with the requirements of Part 10 of the *Election Act*.
