To Ms. Hai Wen Fu, Financial Agent for Nation Alliance Party:


I have audited the annual financial report pursuant to Part 10 of the Election Act of Nation Alliance Party for the year ended December 31, 2007. This annual financial reports is your responsibility as Financial Agent for Nation Alliance Party. My responsibility is to express an opinion on this annual financial report based on my audit.

Except as explained in the following paragraph, I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the annual financial report is free of material misstatement. An audit also includes examining, on a test basis, evidence supporting the amounts and disclosures in the annual financial report. An audit also includes assessing the accounting principles used and significant estimates made by the Financial Agent, as well as evaluating the overall presentation of the annual financial report.

Due to the nature of the transactions of Nation Alliance Party, it is impracticable through auditing procedures to determine that the Financial Agent's Nation Alliance Party records include all financial transactions for Nation Alliance Party. Accordingly, my verification of these transactions was limited to the amounts recorded in the Financial Agent's Nation Alliance Party records and I was not able to determine whether any adjustments might be necessary to the annual financial report.

In my opinion, except for the effect of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself as to the completeness of the Financial Agent's Nation Alliance Party records as described in the preceding paragraph, this Nation Alliance Party annual financial report presents fairly, in all material; respects,

the financial transactions contained in the Financial Agent's records, in accordance with the requirements or Part 10 of the Election Act.
