Filing deadline – August 26, 2016 Late filing deadline – September 26, 2016

The disclosure statement for Ken H. F. Johnston was received by Elections BC on September 23, 2016; however, the \$500 late filing fee was not received by the late filing deadline.

Therefore, in accordance with section 64 of LECFA, this candidate is disqualified from being nominated for, elected to or holding office on a local authority until after the next general local elections.
