Progress Vancouver accepted a \(\$ 50,000\) loan from Jason Maclean in February 2022 which had been solicited to finance the day-to-day administration of Progress Vancouver's elector organization office intended to operate on a continuing basis outside campaign periods. The party inadvertently failed to notice the proclamation as of December 1, 2021 of the Local Elections Statutes Amendment Act, 2021, which it now understands had the effect of deeming all loans to an elector organization to be loans for election expenses and subject to the prescribed limit on loans from non-financial institutions.

Progress Vancouver became aware of the amendments having come into effect only after it had paid bills for the purposes set out above. It hoped to be able to return Mr. Maclean's loan through campaign contributions, but has not been successful to date in doing so. Progress Vancouver continues to solicit permitted donations and intends to repay Mr. Maclean's loan as soon as it is able.
