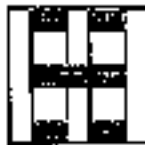

**Auditors' Report on
The Green Party Political Association of British Columbia's
Election Financing Report
Pursuant to the Election Act**

To Ms. Pamela Munroe,
Financial Agent for The Green Party Political Association of British Columbia

We have audited the attached Election Financing Report (pursuant to Part 10 of the *Election Act of British Columbia*) for The Green Party Political Association of British Columbia for the campaign period from April 19, 2005 to May 17, 2005 relating to the Provincial General Election held on May 17, 2005. This election financing report is your responsibility as Financial Agent for the Association. Our responsibility is to express an opinion on this election financing report based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the election financing report is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the election financing report. An audit also includes assessing the accounting principles used and significant estimates made by the Financial Agent, as well as evaluating the overall presentation of the election financing report.

Due to the nature of the types of transactions of any political association, it is impracticable through auditing procedures to verify the completeness of the Financial Agent's political association records. Accordingly, our verification of these transactions was limited to the amounts recorded in the Financial Agent's association records and we were not able to determine whether any adjustments might be necessary to the election financing report.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of the Financial Agent's association records as described in the preceding paragraph, this election financing report presents fairly in all material respects, the financial transactions contained in the Financial Agent's records, in accordance with the requirements of Part 10 of the *Election Act of British Columbia*.

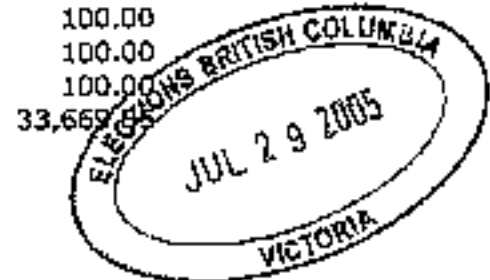
