**Auditor's Report on  
Joe Cardoso's Election Financing Report  
Pursuant to the Election Act**

August 5, 2009

To Bryan Holgate, Financial Agent for Joe Cardoso:

We have audited the candidate's election financing report for Joe Cardoso, relating to the British Columbia election held on May 12, 2009 in the electoral district of Boundary-Similkameen. This election financing report is your responsibility as the financial agent for Joe Cardoso. Our responsibility is to express an opinion on this election financing report based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards and the requirements of section 214 of the Election Act. Canadian generally accepted auditing standards require that we plan and perform an audit to obtain reasonable assurance whether the election financing report is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the election financing report. An audit also includes assessing the accounting principles used and significant estimates made by the financial agent, as well as evaluating the overall presentation of the election financing report.

Due to the nature of the transactions inherent in any election campaign, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these transactions was limited to the amounts recorded in the election campaign records and we were not able to determine whether any adjustments might be necessary to the election financing report.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves as to the completeness of the election campaign records as described in the preceding paragraph, this election financing report presents fairly, in all material respects, the financial transactions contained in the election campaign records, in accordance with the requirements of Part 10 of the Election Act.

This election financing report, which has not been, and was not intended to be, prepared in accordance with Canadian generally accepted accounting principles, is solely for the information and use of the Chief Electoral Officer to comply with Part 10 of the Election Act. The financing report is not intended to be and should not be used by anyone other than the specified users or for any other purpose.
