AUDITOR'S REPORT ON CANDIDATE'S ELECTION FINANCING REPORT PURSUANT TO THE ELECTION ACT

To: Richard Kendrick, Financial Agent for Lakhvinder Jhaj

We have audited the candidate's Election Financing Report for Lakhvinder Jhaj, relating to the British Columbia election held on May 12, 2009 in the electoral district of Boundary Similkameen. This Election Financing Report is your responsibility as the financial agent for Lakhvinder Jhaj. Our responsibility is to express an opinion on this Election Financing Report based on our audit.

Except as explained in the following paragraph, we concluded our audit in accordance with Canadian generally accepted auditing standards and the requirements of section 214 of the *Election Act*. Canadian generally accepted auditing standards require that we plan and perform an audit to obtain reasonable assurance whether the Election Financing Report is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the Election Financing Report. An audit also includes assessing the accounting principles used and significant estimates made by the financial agent, as well as evaluating the overall presentation of the Election Financing Report.

Due to the nature of the transactions inherent in any election campaign, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification.
