INDEPENDENT AUDITOR'S REPORT

To Sacha Peter, Financial Agent for Abbotsford South Constituency Association

I have audited the accompanying deregistration financial report of Abbotsford South Constituency Association for the period ended June 7, 2013. The deregistration financial report has been prepared by the Financial Agent for Abbotsford South Constituency Association based on the financial reporting provisions of Part 9 Division 3 Section 170, 171 and 173 and Part 10 of the *Election Act*.

Financial agent's responsibility for the deregistration financial report

The Financial Agent is responsible for the preparation of the deregistration financial report in accordance with the financial reporting provisions of Part 10 of the *Election Act*, and for such internal control as the financial agent determines is necessary to enable the preparation of deregistration financial reports that are free from material misstatement, whether due to error or fraud.

Auditor's responsibility

My responsibility is to express an opinion on the deregistration financial report based on my audit. I conducted my audit in accordance with Canadian generally accepted auditing standards as required by Section 214 of the *Election Act* (British Columbia). Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the deregistration financial reports is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the deregistration financial report. The procedures selected depend on the auditor's judgment, including the assessment of risks of material misstatement of the deregistration financial report, whether due to error or fraud. In making those risk assessments, the auditor considers internal control relevant to the Financial Agent's preparation of the deregistration financial report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Abbotsford South Constituency Association's internal control. An audit also includes evaluating the appropriateness of accounting policies used and reasonableness of accounting estimates made by the Financial Agent, as well as evaluating the overall presentation of the deregistration financial report.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.

Basis for Qualified Opinion


Due to the nature of the transactions inherent in any constituency association, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, my verification of these transactions was limited to the amounts recorded in the constituency association records and I was not able to determine whether any adjustments might be necessary to the deregistration financial report.

Qualified Opinion

In my opinion, except for the effects of the matter described in the Basis for Qualified Opinion paragraph, the deregistration financial report of the Abbotsford South Constituency Association is prepared, in all material respects, in accordance with the financial reporting provisions of Part 10 of the *Election Act*.

Basis of Accounting

The deregistration financial report is prepared to assist Abbotsford South Constituency Association to comply with the financial reporting provisions of Part 9 Division 3 Section 170, 171 and 173 and Part 10 of the *Election Act*. As a result, the deregistration financial report may not be suitable for another purpose.
