INDEPENDENT AUDITOR'S REPORT

To Susan Low, Financial Agent for Esquimalt Royal Roads Green Party Constituency Association

We have audited the accompanying annual financial report of the Esquimalt Royal Roads Green Party Constituency Association for the year ended December 31, 2013. The annual financial report has been prepared by the Financial Agent for Esquimalt Royal Roads Green Party Constituency Association based on the financial reporting provisions of Part 10 of the Election Act.

Financial agent's responsibility for the annual financial report

The Financial Agent is responsible for the preparation of the annual financial report in accordance with the financial reporting provisions of Part 10 of the Election Act, and for such internal control as the financial agent determines is necessary to enable the preparation of annual financial reports that are free from material misstatement, whether due to error or fraud.

Auditor's responsibility

Our responsibility is to express an opinion on the annual financial report based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards as required by Section 214 of the Election Act (British Columbia). Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the annual financial report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the annual financial report. The procedures selected depend on the auditor's judgment, including the assessment of risks of material misstatement of the annual financial report, whether due to error or fraud. In making those risk assessments, the auditor considers internal control relevant to the Financial Agent's preparation of the annual financial report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Esquimalt Royal Roads Green Party Constituency Association's internal control. An audit also includes evaluating the appropriateness of accounting policies used and reasonableness of accounting estimates made by the Financial Agent, as well as evaluating the overall presentation of the annual financial report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Basis for Qualified Opinion

Due to the nature of the transactions inherent in any constituency association, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these transactions was limited to the amounts recorded in the Esquimalt Royal Roads Green Party Constituency Association records and we were not able to determine whether any adjustments might be necessary to the annual financial report.

Qualified Opinion

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion paragraph, the annual financial report of the Esquimalt Royal Roads Green Party Constituency Association for the year ended December 31, 2013 is prepared, in all material respects, in accordance with the financial reporting provisions of Part 10 of the Election Act.

Basis of Accounting

The annual financial report is prepared to assist Esquimalt Royal Roads Green Party Constituency Association to comply with the financial reporting provisions of Part 10 of the Election Act. As a result, the annual financial report may not be suitable for another purpose.
