#### INDEPENDENT AUDITOR'S REPORT

#### To Michael Goldberg, financial agent for Nicholas Simons

We have audited the accompanying election financing report of Nicholas Simons relating to the British Columbla election held on May 9, 2017 in the electoral district of Powell River-Sunshine Coast. The election financing report has been prepared by the financial agent for Nicholas Simons based on the financial reporting provisions of Part 10 of the *Election Act.* 

#### Financial agent's responsibility for the election financing report

The financial agent is responsible for the preparation of the election financing report in accordance with the financial reporting provisions of Part 10 of the *Election Act*, and for such internal control as the financial agent determines is necessary to enable the preparation of election financing reports that are free from material misstatement, whether due to error or fraud.

#### Auditor's responsibility

Our responsibility is to express an opinion on the election financing report based on our audit. We conducted our audit in accordance with Canadian generally accepted audiling standards as required by Section 214 of the *Election Act* (British Columbia). Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the election financing report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the election financing report. 
