### INDEPENDENT AUDITOR'S REPORT

To Judy Button Financial Agent for Eric Foster

We have audited the accompanying election financing report of Eric Foster relating to the British Columbia (by) election held on May 9, 2017 in the electoral district of Vernon Monashee. The election financing report has been prepared by the Financial Agent for Eric Foster based on the financial reporting provisions of Part 10 of the *Election Act*.

#### Financial agent's responsibility for the election financing report

The Financial Agent is responsible for the preparation of the election financing report in accordance with the financial reporting provisions of Part 10 of the *Election Act*, and for such internal control as the financial agent determines is necessary to enable the preparation of election financing reports that are free from material misstatement, whether due to error or fraud.

#### Auditor's responsibility

Our responsibility is to express an opinion on the election financing report based on our audit. We conducted our audit in accordance with Canadian auditing standards as required by Section 214 of the *Election Act* (British Columbia). Accordingly, our verification of these transactions was limited to the amounts recorded in the election campaign records and we were not able to determine whether any adjustments might be necessary to the election financing report.
