We have audited the accompanying election financing report of Kelly Greene relating to the British Columbia election held on May 9, 2017 in the electoral district of Richmond Steveston. The election financing report has been prepared by the Financial Agent for Kelly Greene based on the financial reporting provisions of Part 10 of the *Election Act*.

Financial agent's responsibility for the election financing report
