To the Chief Electoral Officer of Elections BC:

We have audited the compliance of Fair Vote Canada's Value of Referendum Advertising by Category, Summary of Sponsorship Contributions, Referendum Sponsorship Contributions of Money, Goods or Services with a Total Value Greater than \$250, and Anonymous Contributions reports for the period ended November 30, 2018 with the criteria established by Part 6 – Referendum Advertising, made under the Electoral Reform Referendum 2018 Regulation. Preparation of the schedules in compliance with the criteria established by the provisions of the regulation is the responsibility of the management of Fair Vote Canada.

Entity's Responsibility for the Schedules

The entity is responsible for the preparation of the Schedules in accordance with the financial reporting provisions of Electoral Reform Referendum 2018 Regulation and the accounting guidelines issued by Elections BC and for such internal control as the entity determines is necessary to enable the preparation of Schedules that is free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on this compliance based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance to determine whether Fair Vote Canada complied with the criteria established by the provisions of the regulation referred to above. Such an audit includes examining, on a test basis, evidence supporting compliance, evaluating the overall compliance with the regulation, and where applicable, assessing the accounting principles used and significant estimates made by management.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Schedules. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement in the Report, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation of the Schedules in order to design audit procedures appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the financial agent, as well as evaluating the overall presentation of the Schedules.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis for Qualified Opinion

Due to the inherent nature of the transactions of referendum advertising entities, the completeness of contributions and other revenue and expenses is not susceptible of satisfactory audit verification. Accordingly, our verification of these amounts was limited to the amounts recorded in the accounting records and we were not able to determine whether any adjustments might be necessary to contributions and other revenue and expenses.

Qualified Opinion

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the Value of Referendum Advertising by Category, Summary of Sponsorship Contributions, Referendum Sponsorship Contributions of Money, Goods or Services with a Total Value Greater than \$250, and Anonymous Contributions reports for the period ended November 30, 2018 are in compliance in all material respects, with the criteria established by Section 6 of the Electoral Reform Referendum 2018 Regulation.

Restriction on Use

Without modifying our opinion, the Schedules are prepared to assist the entity to meet the requirements of the Electoral Reform Referendum 2018 Regulation and the accounting guidelines issued by Elections BC. As a result, the Schedules may not be suitable for another purpose. Our report is intended solely for the entity and the Chief Electoral Officer, and should not be used by parties other than the entity or the Chief Electoral Officer.
