## INDEPENDENT AUDITORS' REPORT

To Gordon Rapp, Financial Agent for the British Columbia Conservative Party

### Report on the audit of the Annual Financial Report

#### Qualified opinion

We have audited the accompanying Annual Financial Report of the British Columbia Conservative Party (the "Party") for the year ended December 31, 2019, which includes the Statement of Assets and Liabilities, Statement of Income and Expenses, Summary of Political Contribution, Political Contributions of Money/Property/Services over \$250, Permitted Anonymous Contributions Accepted at Functions, Combined Contributions to Political Party Constituency Association etc., Prohibited Contributions, Summary of Advertising Expenses by Class, Transfers Received and Given and notes to the Annual Financial Report (together, the "Annual Financial Report"). The Annual Financial Report has been prepared by the Financial Agent for the Party based on the financial reporting provisions of Part 10 of the *Election Act*.

In our opinion, except for the possible effects of the matter described in the basis for qualified opinion section of our report, the accompanying Annual Financial Report is prepared, in all material respects, in accordance with the financial reporting provisions specified in Part 10, Division 6, Section 214 of the *Election Act* (British Columbia).

#### Basis for Qualified Opinion

Due to the nature of the transactions inherent in any political party, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these transactions was limited to the amounts recorded in the Party's records and we were not able to determine whether any adjustments might be necessary to the annual financial report. Our audit opinion on the Annual Financial Report for the year ended December 31, 2019 was modified accordingly because of the possible effects of this limitation in scope.

We conducted our audit in accordance with Canadian generally accepted auditing standards as required by Section 214 of the *Election Act*. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Annual Financial Report section of our report. We are independent from the Party in accordance with the ethical requirements that are relevant to our audit of the report in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

#### Emphasis of Matter – Basis of Accounting and Restriction on Use

The Annual Financial Report is prepared to assist the Party to comply with the financial reporting provisions of Part 10, Division 6, Section 207 of the *Election Act* (British Columbia). As a result, the Annual Financial Report may not be suitable for another purpose. Our report is intended solely for the Party, its Financial Agent, and the British Columbia Chief Electoral Officer and should not be used by parties other than the Party, its Financial Agent, and the British Columbia Chief Electoral Officer. Our opinion is not modified in respect of this matter.

#### Responsibilities of the Financial Agent and Others Charged with Governance for the Annual Financial Report

The Financial Agent is responsible for the preparation of the Annual Financial Report in accordance with the financial reporting provisions of Part 10, Division 6, Section 214 of the *Election Act* (British Columbia); this includes determining the applicable financial reporting framework is acceptable for the preparation of the Annual Financial Report in the circumstances, and for such internal control as the Financial Agent determines is necessary to enable the preparation of the Annual Financial Reports that is free from material misstatement, whether due to error or fraud.

Those charged with governance are responsible for overseeing the Party's financial reporting process.

#### Auditors' Responsibility

Our objectives are to obtain reasonable assurance about whether the Annual Financial Report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.



**Auditors' Responsibility (continued)**

Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from error or fraud and are considered material if, individually or in aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of the Annual Financial Report.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgement and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the Annual Financial Report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Party's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management of the Party.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal controls that we identify during our audit.
